## DATA PROTECTION DECLARATION: REGISTRATION FOR AN EVENT OF THE EFRC e.V.

### 1. Purpose and Data Collection Authority

The data collected in this form will be used and processed for the registration for the 13<sup>th</sup> EFRC Conference in Zagreb, September 19 – 21, 2023, held by the European Forum for Reciprocating Compressors e.V. (EFRC).

We collect data in accordance with General Data Protection Regulation (GDPR) Article 6 Paragraph 1(a) in conjunction with § 22 of the Law regarding the copyright for works of graphic art and photography (KunstUrhG).

### 2. Data Processing

The data will be processed electronically by the staff of the EFRC, particular:

- in order to communicate with the participants of the event
- to be able to issue an invoice
- to use them in combination with photos and videos depicting the person
- to inform you on similar future events organised by EFRC.

If the event is held virtually, you consent to the data processing of the video software being used. Your personal data will not be used for other purposes and will not be shared with external parties.

### 3. Transfer of rights and use of pictures and videos

Please note that representatives of the European Forum for Reciprocating Compressors e.V. will take pictures and videos during the conference.

By agreeing with this document, you consent to EFRC publishing your pictures and video recordings set out above in the following manner:

The material will be used for:

- internal distribution to the participants and within the EFRC as well as
- external publication for the purpose of advertisement.

The storage period of your data is limited to 5 years.
